Sir,

With reference to the above subject, permission of SAIL, Rourkela Steel Plant is hereby accorded to use land of SAIL, RSP by Airports Authority of India in an area of Ac. 146.00 in Rourkela Town Unit (RTU) No.2, 6 & 9 for expansion and development of Rourkela Airport as per your Master Plan attached with your letter addressed to Chairman, SAIL as referred above.

The terms and conditions of permission for proposed expansion and developmental project of Rourkela Airport by AAI are as follows :

1. We are pleased to accord permission to take up the construction work as per the Master Plan.
2. That before starting of the construction, GM I/c, Town Services Deptt., SAIL, RSP, Rourkela, may be contacted for showing the exact location of the land.
3. That the land shall be used for the purpose of the construction of the mutually agreed Augmentation Facilities of Rourkela Airport only and for no other purpose.
4. That AAI shall undertake all the work as per mutual agreement in the ambit of the MOU.
5. That several facilities belonging to SAIL, RSP, Rourkela like roads, buildings, water lines, sewer lines, electricity lines, trees, greengages and other installations etc. which may be act as the obstacles for the project and may be affected due to this Airport Expansion needs to be suitably relocated. The cost estimates will be intimated soon and the expenditure towards the same will be from RCS Fund. (Copy of the MoM dated : 15/02/2021 attached).
6. That in the event of any need for removal of trees which may be required during the work, the same may be informed to SAIL, RSP Management for suitable disposal.
7. The existing electricity lines (3 nos. 33 KV Electricity Supply Line & installations) belong to TATA Power Western Odisha Distribution Ltd. (TPWODL) under Govt of Odisha inside the said land is required to be shifted/relocated.
